

# RALLYE DU MAROC PRIZE DRAW

## Terms and Conditions

### Eligibility & Entry:

1. By entering this promotion ("Promotion"), entrants will be deemed to have accepted these terms and conditions and agreed to be bound by them.
2. The Promotion is open to permanent residents of the United Kingdom including Northern Ireland and Channel Islands, aged 18 years and above.
3. The Promotion excludes employees (or family members of employees) of Renault UK Limited trading as Dacia UK (thereinafter "Dacia UK") (the "Promoter"), its retailers, subsidiaries, other group companies, its agents or anyone else professionally connected with this promotion are excluded.
4. The Promotion will run from 00:01 BST on 01.06.2026 ("Opening Time") to 23:59 BST on 15.06.2026 ("Closing Time") (altogether the "Promotional Period"). Any entry received after the Promotional Period will be rejected.
5. No purchase necessary and no guarantee of winning. One entry per person during the Promotional Period is permitted.

### How to Enter:

6. To enter this Promotion, entrants must input the required details to the Moroccan Rally prize draw competition entry webpage hosted by Dacia UK (<https://www.dacia.co.uk/morocco-rally-adventure.html>) by the Closing Time. Any entries received after this time will be rejected.
7. Entries that do not comply with these entry rules and conditions in full will be disqualified.

### Winner Selection and Notification:

8. There will be one (1) winner in total ("Winner") selected by an independent adjudicator from all complete and eligible entries received during the Promotional Period.
9. The Promoter's decision is final and binding in all respects on all entrants and no correspondence will be entered into.
10. The Winner will be notified within 5 days of the Promotional Period Closing Date via the communication method the Winner has specified at the time of entry. If no reply is received within 5 days of notification confirming acceptance of the Prize, the Promoter reserves the right to disqualify the Winner and allocate the Prize to an alternative winner selected in the same manner. No further compensation will be provided to the previous Winner.
11. In the event that, following confirmation of acceptance of the Prize, the Winner is unable to accept the Prize and/or to fulfil the requirements set out in paragraph 16 below, the Prize will be withdrawn, and no further compensation will be provided to the Winner.

    - Day 3 & 4: Cheer on the Dacia Sandriders with access to the rally viewpoint and enjoy a Moroccan meal before returning to Agadir.
14. The itinerary and flight times are subject to availability and will be confirmed with the Winner upon booking by the Promoter's affiliates.
15. Any other costs incurred that are incidental to the fulfilment of the Prize, such as parking, transfers, food and drink (other than that specified) are the sole responsibility of the Winner.
16. The Winner will be responsible for ensuring that they and any person travelling with them are available to travel and hold valid passports, any necessary visas and travel documents for travel, on the travel dates specified. All persons travelling should also have the necessary vaccines or relevant exemption certificates.
