**Object of the contract:**

The object of the contract/supply order is the execution, delivery, installation, commissioning and obtaining performance for the investment project „***Expansion of the vehicle production capacity***”:

  - **Carbody transfer system from Bodyshop to Paintshop**

The bank guarantee is to be released at the end of the actual delivery on the client's site (RCP milestone).

**Award procedure:**

The procurement process consists of two stages:

### **First stage – “Preselection”**

The objective of the stage is to identify potential suppliers who may be eligible for this case - with respects the principles of non-discrimination, equal treatment, mutual recognition, transparency, proportionality and effectiveness of the use of funds. Following the analysis of the results, the selection committee designated by the company will decide the list of suppliers selected for Stage 2 and will receive a call for tender.

Tenderers/suppliers' representatives may participate in the opening of bids on the basis of a copy of the ID/passport. For this purpose, they will be presented at the Beneficiary's with one hour before the time fixed for the opening of tenders. If the participant is not the legal representative of the bidder, it must also present the mandate made for this purpose by the legal representative of the bidder one hour before the deadline for submitting the envelopes.

**Possibility to request clarification:**

There is a possibility to ask for clarifications, within 2 days from the date of publication of the notice on the site.

Responses will be provided by Dacia representatives during a calendar day (24 hours), but the deadline for receiving the answers mentioned below will not be extended.

**Qualification criteria regarding the economic and financial situation of economic operators that could lead to exclusion:**

The amount of prospective cumulative turnover with DACIA - including the batch amount covered by this call for tenders - must not exceed 35% of the total annual turnover of the bidder, including the one estimated for 2018.

**What the return from the first stage should contain:**

The return documents in the pre-selection phase will be sent in an envelope that will be labelled "QUALIFICATION DOCUMENTS" and will be sealed, signed and stamped.

The envelope will contain:

- \* The contract accepted without reserves (signed and stamped on each page) - Annex 1
- \* The Confidentiality Agreement accepted without reserves (signed and stamped on each page) - Annex 2
- \* Statutory statement according to which the participating economic operator is not in one of the situations described in Article 14 and Article 15 of the GEO. no. 66/2011, in original, signed by the legal representative of the company - FORM.1.
- \* The bidder's turnover for 2018 (forecast), including the afferent part of the DACIA, will be presented in a table, signed and stamped.
- \* Candidates must demonstrate that they have completed, in the last 5 years (or starting up), similar projects, and that they have study, design and commissioning competencies on a given surface and planning in a turnkey version, for:
  - 1 preparation and paint finishing line, 15 to 60 vehicles per hour, in Europe or China.
  - have implemented the Siemens automatisms standard for a paint installation.
- \* Formal agreement of the supplier according to which, in case of winning the tender, it will present bank guarantees equivalent to the amount of the advance. The bank guarantee is released at the end of the actual delivery on the client's site.
- \* Valid certification: ISO 9001.

**The second stage - "Selection"**

Participation in this stage is conditioned on the passage of stage 1 "Pre-selection" and only qualified suppliers to stage 1 will participate at this stage.

Launching a call for tenders via e-mail to the suppliers selected in Stage 1.  
Following the analysis of technical and commercial offers, the selection board will decide the winner.

In the second stage, the access of the suppliers that will meet the prerequisites of Stage 1 to the technical specifications will be provided through the FTP server or via e-mail.

**The address where the tenders are sent:**

The sending of the technical and economic tender will be done in two envelopes (one envelope for the technical offer and one envelope for the commercial offer) sent by post or face to face but must reach the address indicated before the deadline announced in the notice;

**The period during which the bidder must maintain its tender valid.**

The validity term of the tender is minimum 60 days.

**Award criteria (most economically advantageous tender or lowest price).**

The award criterion is the lowest price subject to prior technical agreement.
