#### **FAQs**

### What is vehicle scrappage policy?

The Vehicle Scrappage Policy was notified by MoRTH (Ministry of Road, Transport and Highways) in Sept. 2021, aiming to replace old vehicles with modern & new vehicles on Indian roads. According to the new policy, commercial vehicles aged >15 years and passenger vehicles aged >20 years will have to mandatorily go for fitness test and if it fails, then to be treated as End of-Life vehicle which will have to be scrapped through a RVSF (Registered Vehicle Scrappage Facility). Further, this policy also draws several incentives and dis-incentives for scrapping or continuing with the older vehicles.

#### How R.E.Li.V.E works?

The scrap scheme offered by Renault is designed inline with Government notification to support customers. Scrappage bonus is offered to all customers providing a valid COD from RVSF against a new car purchase. The scheme is applicable on all New model/variants. Renault dealership will support customers to process ELV scrapping through the RVSFs.

### What are the benefits of scrapping a vehicle?

Some incentives for scrapping old vehicles and buying new ones are as follows:

- Registration fee Benefits, for new vehicle purchase. States can give up to 25% and 15% rebate on road tax
- Owners can receive scrap value equivalent of 4-6% of ex-showroom price of new vehicles
- All kind of incentives are to be given to seller who has certificate of deposit and scrappage certificates (These certificates can be given by only RVSF license holders)

## How deregistration of scrap vehicles will take place?

All 15 year old vehicles would go for mandatory fitness test in coming years. Unfit vehicles will have the option for a limited period to produce fitness certificate. But if the vehicle owner is failed to do so, then vehicle would be treated as End-Of-Life vehicle and should be deregistered on Vahan Portal with help of RVSF

### How will I get Certificate of Deposit and Scrappage Certificate?

After successful deregistration of the vehicle on Vahan Portal, certificate of deposit would be generated and given to the vehicle owner. Vehicle scrappage certificate to be provided to the vehicle owner after complete dismantling and disposal of the vehicle

## What documents are needed to sell my vehicle for scrapping?

- Original registration certificate
- PAN card of registered owner
- KYC of registered owner (Aadhar card OR Passport OR Voter ID of registered owner)
- Address Proof
- Vehicle Ownership proof
- Cancelled cheque of registered owner/Bank details with IMPS facility
- Loan closure certificate or NOC

## Can I scrap a vehicle from other state or city?

Yes. Now, there is a single portal on Vahan to deregister the vehicle. This enables any vehicle to be scrapped anywhere in India. Scrap your old vehicle at anyRVSF facility near you.

#### Can I scrap the vehicle if I have outstanding loan on the vehicle?

All outstanding loan and legal cases to be paid & resolved by the vehicle owner before initiating the vehicle scrappage activity.

# Can I trade certificate of deposit, if I do not want to use it?

Yes. For reference the CODs are traded on a govt approved platform
